2. No support will be given to licensed events or functions that serve wine that is not that of Frisky Beaver Wine Co, Smoke & Gamble Cellars, or RapsCALLION Wine Company.
3. Frisky Beaver Wine Co, Smoke & Gamble Cellars, and RapsCALLION Wine Company does not provide direct financial donations or sponsorships.
4. Frisky Beaver Wine Co, Smoke & Gamble Cellars, and RapsCALLION Wine Company does not provide support for events or activities deemed to be of a personal nature. Examples include: Stag & Does, Retirements, Trip fundraisers, etc.
5. As a licensed winery, Frisky Beaver Wine Co, Smoke & Gamble Cellars, and RapsCALLION Wine Company cannot provide direct support to youth or youth related activities.
